Supervisors Report

License Application for new Iron Furnace – Motion

Councilman Welsh made a motion to agree to their request to waive the 30-day waiting period for the SLA send a letter of no opposition which was seconded by Councilman Cartalemi and all were unanimously in favor.

Flooring Senior Center/ Library

Supervisor Frazier explained the Library wants to carpet a section of the senior center, both parks and rec approached the Supervisor in regard to maintenance with summer camp utilizing the room rather than the tile floor. Head of senior center president is concerned with tripping hazard. Councilman Welsh is also worried about the leaking roof on the new carpet. The other issue is that this is a temporary space and the total cost is around \$6,300.00

Motion to Table Flooring in Temp Library

Councilman Welsh made a motion to table this purchase until the roof is completed and resume conversations at a later time seconded by Councilman Cartalemi and all were unanimously in favor.

Old Business

Archives Room A/C

Supervisor Frazier had all companies quoted also add a 1-year warranty of workmanship. Crown would not warranty equipment failure, others did not mention. The only difference is the warranty from Folks, difference of \$1100 as this represents the best value the board liked this option. Funded by building maintenance line and there is 40,000k. After review Folks did not include the air handler, the decided Temp Control was the best value.

Motion to Award A/C for Archives Room Quote

Councilman Cartalemi made a motion to accept quote from Temp Control to repair the archives room A/C unit for total of \$9,880.00 seconded by Councilman Welsh and all were unanimously in favor.

Fuel Discussion- Councilman Cartalemi explained his research in obtaining reduced prices for fuel. The only issue is it would be from different vendors to achieve competitive pricing and a substantial savings. #1 Global Montello out of Newburgh offered on road diesel, unleaded gas. #2 Hop Energy LLC / Costco Heritage out of Kingston and #3 Paraco as the propane distributor.

Pricing is regulated by NYS bid, all have been awarded contracts thought the NYS Office of General Services. These must perform from a service perspective to keep their status on the state award contracts. After a quick estimate Councilman Cartalemi stated the savings can be around a total of \$7000-\$8,000 year. Everyone agreed this would be a smart and cost-effective decision.

Motion for Fuel Contracts

Councilman Cartalemi made a motion for the Supervisor to sign and documents or anything else necessary to obtain NYS bids with those contractors which was seconded by Councilman Welsh and all were unanimously in favor.

Handbook Discussion Supervisor Frazier is still waiting for Dutchess County HR to get further direction about combined positions. Full time status is listed as 35 and 32 hours, with the hours at town hall they don't have the opportunity to work those hours. Town Board must determine the house for full time and benefits. These positions need to be standardized also for proper PTO calculations. Councilman Cartalemi's only concern is how many more people could qualify for benefits that would impact the town financially but agrees they need to clean that up. Supervisor will get that list, to see who qualifies.

Public Comment on Town Issues

Richard Ott, Riley Road, wanted to follow up rt 55 intersection questions, questioned about what list was mentioned about the intersection and had other questions on the safety and adjustment of that intersection He would like a right-hand turn lane to resolve many of the issues.

Approve Budget Adjustments, Transfers, Warrants, Pay Bills

Councilman Welsh made a motion to pay the bills and which was seconded by Councilman Cartalemi and all were unanimously in favor.
